REVISED TERMS & CONDITION FOR 3RD ROUND OF UG AYUSH COURSES COUNSELLING FOR ACADEMIC SESSION 2024 - 2025

1. In case there is vacancy after the 2nd round of counselling due to any reason or new/additional seats of any course, if any participating college/institute/ university would get the permission from the concerned statutory agencies, all such seats will be filled up during the 3rd round of counselling.
2. Fresh registration shall be allowed for participating in the third round. Fresh candidates will have to register themselves on the admission web portal (at the given link <https://skau.online-counselling.co.in/>). The candidates will have to **deposit the fee online** (at the given link <https://skau.online-counselling.co.in/> to the Shri Krishna AYUSH University, Kurukshetra at the time of joining, failing which his/her admission shall stand cancelled.
3. The **personal appearance** of the candidates at the time of joining and **document verification** at the concerned allotted college is mandatory.
4. Any order of the Hon'ble Supreme Court/Punjab and Haryana High Court/ Amendments by the State Government/India Government/Ministry of AYUSH, GOI/NCISM (CCIM) shall be applicable at any stage.
5. **Eligibility Criteria** for BAMS, BSMS, BUMS & BHMS Degree courses will be as per Information Bulletin of NEET (UG) – 2024.
6. As per Information Bulletin of NEET (UG) – 2024, no candidate shall be admitted to BAMS, BSMS, BUMS & BHMS Degree courses unless he has **attained the age of 17 years on or before 31st December of 2024** of his admission in the first year of the course and The NCISM and NCH have jointly decided not to insist any upper age limit for candidates seeking admission in ASU & H (BAMS/BSMS/BUMS/BHMS) undergraduate 3rd courses for the academic year **2024-25, i.e. there is no upper age limit for admission in ASU & H-UG courses.**
7. The candidates, who have already registered themselves for 1st & 2nd round and wish to participate in the 3rd round, shall not be required to register again. However, all the candidates irrespective of the round they have registered shall have to submit a declaration, fill the preference/choices and pay the security fees after login to the counselling portal for participating the 3rd round of online counselling.
8. The candidate who wish to participate in the third (3rd) round of counselling and want to opt for State Quota Seats in Shri Krishna Govt. Ayurvedic College, Kurukshetra & MSM Institute of Ayurveda, Khanpur Kalan, Gohana, Sonapat **only** shall be required to submit **Rs. 5,000/- {Rs. 2500/- for SC/D-SC/BC/EWS/PWD/ESM/FF* of the State of Haryana (*if applicable)}, as Security Fee** at the time of fresh registration/choice filling for 3rd round of counselling.
9. If the candidate wishes to opt for State Quota seats in **Government as well as/or State Quota Seats/ Management Quota seats** in Private BAMS/BHMS Institutes/Universities then he/she will have to deposit **Rs. 50,000/-, as Security Fee** at the time of fresh registration/choice filling for 3rd round of counselling.
10. If a candidate does not deposit the requisite amount of Security Fee then he/she **shall not be eligible** to participate in the third round of counselling.
This amount shall be later **ADJUSTED** in the fee of first year course, if the candidate joins the allotted seat; The Security money will be **FORFEITED**, if a candidate who has been allotted a seat and does not join the respective institution or surrender the seat due to any unforeseen reason before and after joining. Also the Security Money will be forfeited, if the admission gets cancelled due to any reason on the part of student. i.e. in case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting or fails to produce the required documents at the time of admission (within the stipulated time) and **REFUNDED (after following the process of refund)** in case no seat is allotted.

The candidates who have been allotted and reported for seat in the 2nd round shall have a right to retain already allotted seat and this shall be changed only if he/she gets an updated and opted seat during 3rd round. However, the candidates who wish to participate in the 3rd round of online counselling will have to submit their preferences afresh again. Candidates, who have been allotted, seat in 2nd round should give the fresh choices in order of preferences for the College/ Course in which they wish to upgrade themselves.

11. The candidates will have to deposit the tuition fee online at the link given above to the Shri Krishna AYUSH University, Kurukshetra at the time of joining, failing which his/her admission shall stand cancelled.
12. All documents must be **produced in original**, documents like Matriculation (10th), Senior Secondary (10+2), Character certificate issued by the last attended college/institute, Haryana Resident Domicile, NEET-2024 score Card, Benchmark Disability, Proof of Identification, Caste Certificate or any other relevant document/certificate as per notification **alongwith two sets of self-attested photocopies and four photographs**. In case the students already deposited the original documents in any other institute/college then, he/she have to produce the receipt of that institute/college regarding documents with an undertaking to submit the original document within a stipulated time as decided by the concerned allotted college.
13. For PwD seat candidate has to produce **relevant certificate** of Benchmark disability issued by appropriate institution mentioned in **Annexure-V of notification**.
14. Candidate has to submit an undertaking in the form of **affidavit** that he/she is not pursuing UG (BAMS/BHMS) course in any institute, anywhere in India.
15. a) If any **discrepancy/false statement in the documents** of the candidate found therein subsequently at any stage, his/her admission shall stand cancelled.
b) If any dispute/issue arises, in this regard the decision of the concerned college admission committee shall be final in consensus with the UG (BAMS/BHMS) Admission Committee – 2024-25 notified by the State vide notification dated 29.08.2024.
16. Any kind of grievance will be entertained only by raising a ticket on the admission portal.
17. College concerned will constitute a **document verification committee** which will verify all the document of the student with their sole responsibility.
18. In future, if any discrepancy or report of fake document is received in that **case student and college will be responsible for cancellation of admission**. The fee will be forfeited and seat will remain vacant.
19. Any admission made by any private AYUSH college/institute those under private university in the state **at its own level shall not be valid and such admission shall be considered null and void**.
20. **If any dispute/issue arise, the decision of Shri Krishna AYUSH University, Kurukshetra shall be final.**
